


Hotel Reservations

The US GEOTRACES Project Office has been invoiced for the cost of the hotel rooms and tax. Since you are however responsible for any incidental charges (which may be submitted for reimbursement after the meeting), the hotel will request credit card information from you to hold your reservation. Your card will not be charged until after you check out and you may change the credit card between now and your check-out date.

Deadline

The deadline to secure your hotel reservation is **Friday, 19 August 2011**. Your room is <u>not</u> guaranteed after this date and you will be responsible for your own room charges if you reserve after this date.

Maximum Lodging Limit

The maximum lodging limit is \$122.73 per night (inclusive of tax). The U.S. GEOTRACES Project Office cannot reimburse you beyond this amount if you choose to be responsible for your own accommodations at another hotel.

Early Departure Fees:

In the event that you have requested a room within the U.S. GEOTRACES block and decide to check out prior to your reserved checkout date, the Sheraton La Jolla Hotel will add an early checkout fee of \$75.00 to your individual account. If you wish to avoid an early checkout fee, please advise the Sheraton La Jolla Hotel at, or before check-in of any change in your planned length of stay. The Sheraton La Jolla Hotel will also inform you of this potential charge upon check in. The Project Office will reimburse the cost of this fee only if it is imposed due to cancellations or changes in travel arrangements required for business needs. This fee will be approved for reimbursement with your attached justification.


Ground Transportation

Airfare

If you will be arriving from outside the U.S., please note that you must use an American carrier in order to receive reimbursement. Code shared flights must have the name and flight number of the American carrier on the ticket. For example, code shared flights between United Airlines and TAP Portugal must be listed on the flight itinerary as

United – Flight 9600 / Operated by TAP Portugal

And NOT as

TAP Portugal – Flight 104 / Operated by United

The former is reimbursable; the latter is not.

You may request reimbursement for airfare prior to the meeting.
